## Article I. ORGANIZATIONAL NAME

The name of this association shall be Shenzhen International Schools' Athletic Conference hereinafter referred to as SISAC.

## Article II. MISSION STATEMENT

The mission of Shenzhen International Schools' Athletics Conference is to promote healthy opportunities for participation in competitive sport for Junior, Middle and High School students. This will be achieved by providing regular, structured sports events for International School students in Shenzhen. The emphasis of all sporting contests will be on fair play, teamwork, and respect.

## Article III. MEMBERSHIP

Section III. 1 MEMBER SCHOOLS

Every consideration is made to maintain membership status for founding member schools.

## Section III. 2 MEMBERSHIP RESPONSIBILITIES

 All Member Schools:1. Must abide by the member schools' rules and protocols.
2. Must abide by the Articles of the Handbook, rules, and regulations and by-laws of SISAC
3. Must provide a nurse, doctor or designated medical professional for games.
4. Have representation at all SISAC meetings pertaining to their school and the division.
5. Annually provide a middle school (U14) and a high school (U19) male and female team for Soccer, Basketball and Volleyball (3 Core Sports). Provide justification when this condition cannot be met.
6. Endeavour to field a team at the middle and high school level in all invitational sports badminton, cross country, swimming, track and field.
7. Are responsible for providing adequate facilities and officials for league games, play-offs and invitationals.
8. Are invited to participate in Junior School events (U9 and U11). Participation is not required as part of full membership. Junior school events are set for SISAC member schools only but may include candidate schools.
9. Are responsible for the cost of travel to away games throughout each season.
10. Are responsible for hosting play-off events at least once per year at both the middle school and high school level.
11. Must ensure that its teams wear uniforms which distinguishes their school.
12. Must provide a contact person for all events (activities/athletic director).
13. Must have at least one English-speaking supervisor present at each event
14. Must participate fully (both hosting and attending) in boys' and girls' volleyball, basketball, and soccer during the probationary years (Article II);
15. Must host the required number of SISAC events as agreed upon by Member Schools at the SISAC AD Spring meeting; (2 events)
16. Expected to follow the standard of official communications to be shared by email including official documents. Athletics Directors are expected to use email as a primary form of communication for discussions and planning. WeChat should only be used for event communication or collecting season results or information

## Article IV. GOVERNANCE

Shenzhen International Schools Athletic Conference or SISAC will be operated by a two-tier governance structure consisting of the SISAC Heads Council and the SISAC Athletic Directors committee, representative from each school, normally the Athletic Director.

## Section IV. 1 OVERSIGHT

The SISAC Heads Council oversees the operation of SISAC. The SISAC Heads Council is composed of the Head or designate from each SISAC member school.

## Section IV. 2 SISAC REQUIRED MEETINGS

(a) HEAD COUNCIL MEETINGS

1. The Heads Council will meet in the Fall (September/October) and Spring (May/June) following the SISAC Athletic Director Meeting.
2. The Heads Council is led by the SISAC Heads Council Chair.
3. The Heads Council reviews all motions passed in the SISAC Athletic Director Meeting.
4. A quorum of $75 \%$ of the Heads Council must be present for any motions to be reviewed.
5. A $75 \%$ majority of votes are required to pass any motion at the Heads Council.

## (b) ATHLETIC DIRECTOR MEETINGS

1. SISAC Athletic Directors will meet in the Fall (August/September) and Spring (April/May).
2. Each SISAC member school must send one delegate to the SISAC Athletic Directors meeting.
3. The SISAC Athletic Directors meeting is led by the AD SISAC Chair.
4. Motions for changes must be submitted to the SISAC AD Chair at least two weeks prior to the meeting.
5. Each member school is permitted one vote on motions floored at the meeting. There must be a majority vote in order for a motion to be passed. ADs must abstain from any voting on any issue that does not apply to its Division.
6. All passed motions are submitted to the SISAC Heads Chair.

## Article V. MEMBERSHIP APPLICANTS

## Section V. 1 MEMBERSHIP POLICY \& PROCEDURE FOR NEW MEMBERSHIP

Prospective schools seeking SISAC membership must:

- Review membership requirements outlined in the SISAC Handbook before applying
- Complete the online application form on the SISAC website before January 1st, 2022

It is the role of the AD Executive Committee to review the candidate school's application. In reviewing the application, may conduct a site visit, meet with the school leadership and candidate school's AD in order to develop a recommendation for membership.

Factors that are considered in a candidate school's membership include the schools:

- Demographics, size and location
- Curriculum
- Athletic philosophy
- Membership with any other sporting organizations
- Alignment with SISAC seasons
- License
- Ability and willingness to abide by the SISAC rules and regulations

The Executive committee is responsible to present their findings to the Athletic Directors representatives at the Spring SISAC Athletic Director's Meeting. A recommendation regarding the application is compiled and sent to the Heads Council as a motion.

The Executive Committee presents the recommendation to the Heads Council. Members of the Heads Council may ask the members of the Executive committee for clarification regarding the application.

A decision on a SISAC membership application is made by the Heads Council. Acceptance or Rejection of the application is communicated by the Heads Council Chair to the candidate school, and the SISAC Athletic Director Executive.

If a candidate school is accepted, the SISAC Athletic Director Executive begins preparations to admit the school within the league's designation.

Once accepted, the candidate school has full voting rights in the Heads Council meeting and Athletic Director meeting.

If a candidate school is rejected, it may apply again in the following year through the same process and timeline. The Heads Council is not required to provide a justification for the rejection of application.

## Section V. 2 FAILURE TO MEET MEMBERSHIP REQUIREMENTS

All member schools must endeavor to fulfill SISAC membership requirements.

Any perceived failures of member schools to meet the membership requirements should be forwarded to the Executive Committee.

The Executive Committee will notify the school of concern's AD of a perceived failure to meet the membership requirements in writing and copied to all SISAC ADs. The Executive Committee will seek a resolution to the perceived failure of the membership requirements with the school of concern's AD. A letter outlining the resolution is sent to the SISAC ADs.

Serious or repetitive, or unresolved perceptions of failure to meet membership requirements must be reported to the Head Council through the Head Council Chair.

## Section V. 3 LOSS OF MEMBERSHIP

All member schools must fulfill SISAC membership requirements. Member schools that exhibit serious or repetitive failures to meet the membership requirements as determined by the SISAC Heads Council, will be placed on probation for one academic year.
During the probationary period, the school must demonstrate that it can consistently meet the membership requirements.

At the end of the probation period, the Heads Council meets to determine:
i. Full reinstatement as a member school.
ii. A one-year extension of probation.
iii. Revocation of membership.

Note: Probationary schools retain their right to vote.

## Article VI. SISAC HEADS COUNCIL \& SISAC EXECUTIVE COMMITTEE

## Section VI. 1 SISAC HEADS COUNCIL

(a) COMPOSITION

- The Heads Council consists of the Head or designate from each SISAC member school.
- A Heads Council Chair is selected from the Heads Council each year at the Spring meeting.
- Should the Heads Council Chair be unable to serve his or her term, a new Chair will be selected at the fall meeting.
(b) DUTIES
(i) Duties of the Chair
- Attend all meetings
- Prepare the agenda for meetings.
- Serve as the contact person for the AD Executive Committee.
- Seeks continuous improvement of SISAC.
(ii) Duties of SISAC Heads
- Represent their school's interest.
- Select and support an AD or designate to represent their respective school at SISAC AD meetings.


## Section VI. 2 SISAC AD EXECUTIVE COMMITTEE

(a) COMPOSITION

- The SISAC Executive Committee will consist of the Chair and one Co-Chair.
- Elections will be held annually at the Spring AGM. Member schools are permitted one vote each.
(b) DUTIES
(i) Duties of The Chair
- Shall attend all meetings of the conference. i.e., AGM, Fall meeting, Executive etc.
- Shall prepare an agenda for the AGM/Fall meetings - email this to member AD's in advance.
- Shall update the SISAC Handbook
- Shall be the main source of contact between member schools and their AD's
- Will seek ongoing improvement of SISAC and its competitions


## (ii) Duties of The Co-Chair

- Shall attend all meetings of the conference. I.e.; AGM, Fall meeting, Executive etc.
- Shall assist in the fulfillment of all of the duties of the Chair as needed
- Collect weekly results via WeChat and update the SISAC website
(iii) Duties of all School Representatives (AD's)
- Are appointed by the school and shall represent the school in all SISAC matters. A representative of a member school should be the Athletic Director, Activities Director, or a qualified teacher in a comparable position within the school's organizational structure.
- Shall host weekly/bi-weekly league games
- Shall host one annual play-off event at both MS and HS level
- Ensure coaches report weekly results via WeChat to the SISAC Chair
- Vote on all motions raised at the AGM
(c) SISAC EXECUTIVE TERMS
(i) SISAC Chair

At the end of a term or an announced vacancy, the member Athletic Directors/designated representatives will vote at the Spring AGM to recommend a new SISAC Chair. He /she must be an Athletic Director (or equivalent title) from a member school who has been at a member school for at least one year. Maximum term for the Chair is 3 years.

## (ii) SISAC Co-Chair

At the end of a term or an announced vacancy, the member Athletic Directors/designated representatives will vote at the Spring AGM to recommend new SISAC Co-Chair(s). He/she must be an Athletic Director (or equivalent title) from a member school. The Co-Chair position(s) will be re-elected every 2 years with nominations accepted from any current Athletic Directors (or equivalent title).
(d) SISAC EXECUTIVE COMMITTEE FOR 2023-2024
a. CHAIR - Allan Moore (SWIS) - 2025
b. CO-CHAIR - Thomas Mathews (SIS) - 2024

## Article VII. EXPENSES

- Each school is responsible for all their team costs (equipment, uniforms, coaches, facilities).
- Each school is responsible for providing officials of both adequate quality and quantity for all sports, excluding basketball
- 5 Star Sports is the official association contracted to referee all SISAC basketball games
- All schools must pay the shared fee associated with refereeing costs payable directly to 5 Star Sports
- If a school does not pay the fee, refer to Article VI regarding disciplinary action
- Each school will host one play-off event each year. The host school is responsible for the cost of this event.


## SISAC BY-LAWS

## BY-LAW A. STUDENT ELIGIBILITY

## i.JUNIOR SCHOOL (U9)

Students participating in SISAC-JS U9 events must be enrolled in Primary school (grade 2-3 or years 3-4)

- Students born in $\underline{2014}$ but enrolled within primary school grades 4-5 or years 5-6 (U11) are permitted to play SISAC-PS U9 sports.
- Girls of the correct age level are permitted to participate on boys' teams whenever a girls' team does not exist for them to participate on.


## ii. JUNIOR SCHOOL (U11)

Students participating in SISAC-JS U11 events must be enrolled in Primary school (grade 4-5 or years 5-6)

- Students born in $\underline{2012}$ but enrolled within middle school grades (grade 6+ or year 7+) are not permitted to play SISAC-PS sports.
- Girls of the correct age level are permitted to participate on boys' teams whenever a girls' team does not exist for them to participate on.


## iii. MIDDLE SCHOOL (U14)

Students participating in SISAC-MS events must be enrolled in middle school (grade 6-8 or years 7-9)

- Students born in $\underline{2009}$ but enrolled within high school grades (grade 9+ or year 10+) are not permitted to play SISAC-MS sports.
- Girls of the correct age level are permitted to participate on boys' teams whenever a girls' team does not exist for them to participate on.

Schools must be prepared to provide proof of age to the tournament director if requested.

## iv. HIGH SCHOOL (U19)

Student's participating in SISAC-HS events must be enrolled in high school (grade 9-12 or years 10-13)

- Middle School students are eligible to play in High School teams as long as it is not at the expense of a High School student. The purpose should be to fill a team roster to the minimum required (see sport rules) and not used to gain a competitive advantage.
- Girls of the correct age level are permitted to participate on boys' teams whenever a girls' team does not exist for them to participate on.

Schools must be prepared to provide proof of age to the tournament director if requested.

Any applications for the use of underage players should be submitted to the SISAC Executive by completing the SISAC Underage Athlete Application Form prior to the first league game.
v. TRANSGENDER STUDENT ATHLETES

SISAC aims to support transgender students while also being conscious of the safety and wellbeing of all students. Each case will be handled by the host school and participating schools.

## i.DIVISIONAL ALIGNMENT

In SISAC core sports (volleyball, basketball and soccer) there will be a maximum of 7 teams per division. With 8 teams or more the following is recommended:

- Two divisions of 4
- One five team and one 4 team division
- Two 5 team divisions
*it is recommended that teams play a maximum of 6 league games and a minimum of 4(3), excluding play-offs
- Divisions are confirmed at the fall meeting and based on the season's final standings.
- When required, each school will receive points for their placement in each of the major sports (volleyball, basketball, soccer) for the season. For example, Girls HS Volleyball winner will receive 7 points, 2nd place will receive 6 points, etc.
- A school's combined total from HS boys and girls core sports will be used to determine seeding.
- A schools combined total from MS boys and girls core sports will be used to determine seeding

## BY-LAW C. SISAC SEASONS

To promote equality among all SISAC schools of various sizes, teams will not compete in regulated competitions or run formal team practice outside of the SISAC season. Seasons may vary slightly each year to accommodate membership in additional organizations. Season dates for each sport will be determined at the annual SISAC Spring Meetings. A two-week 'grace' period will be allotted [to use at the school's discretion] to practice, hold camps or participate in games outside of a team's competitive season.

Elementary School core sports will take the form of half day tournament/exchange. Event organizers must follow established and approved tournament formats (see Tournament Format

Appendix) set forth by the SISAC organization. Any change in format must be approved by the Executive Committee at least one month in advance of the event.

## BY-LAW D. LEAGUE PLAY

## i. LEAGUE PLAY

During the league season, each school will play every other school at least once within the division or pool in their division/pool, (Article XII). A running league table will be kept by the SISAC Exec and posted on the SISAC website.

## ii. LEAGUE TABLE POINTS

Teams will be awarded the following points based on the result:

- 3 Points for a win
- 1 Point for a draw
- 0 Points for a loss
- 0 Points for DNP
- *A withdrawal will be counted as a loss
- ** DNP due to inclement weather will count as a draw
- (SISAC Exec should be notified immediately)
iii. PLAY-OFF STRUCTURE
(a) 7 Team League

After all league games have been played, the schools in the top 4 positions in the league will qualify for the play-offs. They will proceed directly to the semi-finals where $1^{\text {st }}$ will play $4^{\text {th }}$ and $2^{\text {nd }}$ will play $3^{\text {rd }}$. This will be followed by the final to determine the season's champions.

(b) 8 (or more) Team League

After all league games have been played, the schools in the top 2 positions of each pool will qualify for play-offs. They will proceed directly to the semifinals, with the winners from each pool playing the runners up in the other. This will be followed by the final to determine the season's champions

* If the 2 pools contain 4 teams in each, then the same style of play-offs as mentioned above, will be played for the bottom two teams in each pool.


## (c) Playoff Eligibility - Participation

If a team has not scheduled all of their games before the season begins (defined as the first competition between 2 SISAC schools), then they are ineligible for the playoffs.
Teams that do not play the majority of their season scheduled games (defined as 4 games participation in 6,7 or 8 team formats) will be ineligible for the playoffs.

## iv. TIE BREAKING PROCEDURE

Refer to core sport SISAC Sport by-laws if two or three teams are tied at the end of their respective season

If four teams are tied at the end of their respective season, the following will determine the order of standings:

1) Head-to-Head records between tied teams
a) Head-to-head results between teams with best records [between tied teams]
2) Point (football/basketball) or set differential (volleyball) between those (2) teams
3) Overall point differential
*For all 3 core sports, the league trophy (shield) will be presented to the school finishing in $1^{\text {st }}$ place.

## v. ALL STAR TEAM

Each Play-Off Event will also see an all-star team awarded with individual medals.

- Teams who qualify for a play-off event will get $\mathbf{3}$ selections, per team
- Teams that don't qualify for a play-off event will get $\mathbf{2}$ selections, per team
- The all-star team will be determined based on the head coach selecting students from their team.
vi. HOST SCHOOL EXPECTATIONS

For league games and play-offs, the host school is expected to provide:

- Suitable facilities to host the specific sport
- All equipment including warm up balls
- Knowledgeable referees who will remain entirely neutral
- Provide certified medical staff at every league game and tournament
- Traveling plaque available from previous years winners
- Winning team to update
- All-Star Team Individual Medals (For Play-Offs Only) x12
- All-Star Team Individual Medals (For non-Play-Offs Teams) - 2 per school as required
- Medals for $1^{\text {st }}$ and $2^{\text {nd }}$ place winners (For Play-Offs Only) x15
- Provide Event Information/ Packages as follows:
- 1 month prior to invitationals
- 1 week prior to playoffs
- Confirm hosted games with visiting schools, including location, times, jersey colors
*For all 3 core sports, the league trophy (shield) will be presented to the school finishing in $1^{\text {st }}$ place.
If a school fails to meet the expectations above, disciplinary action may occur. Please refer to Article VI.


## BY-LAW E. GAME DAYS

Scheduling will be completed at the Spring AGM:

1) Middle School games and play-offs will be encouraged to take place on Thursday afternoons.
2) High School games and play-offs will be encouraged to take place on Monday afternoons.
3) Matches will begin at 16:00, unless stated in the schedule or agreed upon otherwise between both teams
4) Schools are expected to have 2 adults travel to game venues for safety purposes.

Note that any exception to the above will be reflected in the SISAC Calendar prior to the beginning of that academic year.

## BY-LAW F. INCLEMENT WEATHER GUIDELINES

These guidelines are meant to act as a baseline, all SISAC schools will abide by when hosting or attending any event. Host schools can add additional school or venue-specific protocols and procedures.

Safety is the greatest priority. Any event may be canceled by the host if it is viewed as unsafe.

1) Decisions to cancel an event must be made by the host and communicated to all participating schools by 14:00 at the latest.
2) In the event that a soccer/touch rugby match starts but is stopped during play.
a) If 25 mins or more of a soccer/touch rugby match have passed, it will be called as a final score.
b) If less than 25 mins have passed, teams will attempt to reschedule the match. If the match cannot be rescheduled both teams will record a draw.
i. AIR POLLUTION
3) Outdoor activities shall be postponed if the Air Quality Health Index (AQI) is 200 or above at the GENERAL station closest to the venue where the event is to be held.
4) If your school policy is below the 200 then it is your school's responsibility to contact the opposition with adequate time.

THUNDERSTORM WARNING

1) The Meteorological Bureau of Shenzhen Municipality warning signals should be used as advice; however, localized weather conditions will be used in making the final decision.
2) Orange/Red Rain Warning:
a) Outdoor activities shall be postponed if an Orange or Red Rainstorm warning is in place at the time of the event.
iii.

TYPHOON SIGNAL
Outdoor activities shall be postponed if a Yellow Typhoon warning is issued or imminent at the time of the event.

In the case of high temperatures, it is the responsibility of the schools involved to take appropriate precautions. Risk needs to be identified, monitored, and managed appropriately. If the Meteorological Bureau of Shenzhen Municipality issues a Yellow warning, staff at fixtures should strictly monitor participants, provide regular and mandatory water breaks during competition and make use of shade when possible. In the eventuality of a heat index of 37 degrees Celsius outdoor activity should be postponed/canceled.

- Made basket beyond the arc worth 2 points, all other made baskets worth 1 point

- Teams must consist of 4 boys and 4 girls - each team will have a boy $\&$ girl singles player, a boy and girl mixed doubles player, and 2 boys and 2 girls doubles players.
- Schools must register a full complement of 8 players. If a team has a late injury or sickness and cannot bring a full complement, arrangements will be made to allow a player to substitute as per detailed below.
- At registration of a team, coaches will designate which players will be playing in which events (singles, doubles or mixed doubles). This event designation will be used
throughout the tournament and can only be altered in the case of an injury as per procedure below.
- In the event of an injury or sickness, one of the remaining players will be designated to play all of the remaining matches for the injured player for that day. Should the player not be able to play on subsequent days, the same substitute player must be used for the remainder of the tournament. The selection of the substitute will use the following procedure only:

1. If the injured player is the singles player or either of the doubles player, they will be replaced by the mixed doubles player.
2. If the injured player is the mixed doubles player, they will be replaced by either of the doubles players.
3. The singles player may not be used as a substitute

- If a team has a second injury or sickness that takes their team below 3 boys or 3 girls, that team will forfeit all remaining matches that the second injured player was scheduled to play.
- Tournament Equipment
- Tournament Shuttles to be used are Mavis 500 Blue Cap (middle)
- All players must have their own racquets, wear team uniforms and indoor court shoes with non-marking soles.
- Tournament Play
- A "rubber" between two teams involves a best out of 5 matches. These are:

1. Girls Doubles
2. Boys Doubles
3. Mixed Doubles
4. Girls Singles
5. Boys Singles

- Winning team is the team that wins 3-2, 4-1, or 5-0
- All 5 matches must be played out to complete a rubber between each team, as each - individual event result as well as the overall team result will be recorded
- Individual events will be recorded separately so that the top two players/doubles teams will be determined from the round robin tournament results
- Matches are the best out of 3 games using the Rally Point scoring system
- Players change ends at the end of each game, and when one side reaches 8 points in the last game.
- The side that wins a game serves first in the following game.
- Players may take a 30 second rest between 1 st and 2 nd games of a match and 1 minute rest between the 2 nd and 3 rd games; players may receive coaching in these times but may not leave the court. No coaching


## BY-LAW I. INVITATIONAL SPORTS

Member schools may choose to host one-day tournaments for other sports. The rules should be based on standard international federation rules, with adaptations where necessary at the
discretion of the event director. These adapted rules are to be made known to competing schools no less than two weeks prior to the event. If, after the initial staging of an event, SISAC intends to make it an annual event, a set of rules should be decided on during the Spring meeting.

Medals will be given to 1st, 2nd, and 3rd place winners of each age group at invitational competitions.

## i. AGE ELIGIBILITY FOR INVITATIONALS

Age groups for invitational events will follow those outlined in ByLaw A of this document.

## BY-LAW J. CODES OF BEHAVIOUR

## i. COACHES BEHAVIOUR

- The intention of SISAC is to promote healthy, competitive sport for our students. Winning should be congratulated, but emphasis should be placed on participation.
- Student-Athletes should be encouraged rather than berated or criticized.
- Be reasonable in your demands of student athletes in terms of playing time, energy and enthusiasm.
- Ensure that each game is a positive experience for the students. The aim is to promote life-long healthy living through the enjoyment and love for sports.
- Avoid criticizing officials. Coaches should set the example to their students. Disputes will be settled between both teams' captains and the officials.
- Ensure that all equipment and facilities are up to health and safety standards.
- Respect the rights and worth of every student-athlete, regardless of their gender, age, ability, ethnicity or religion.


## ii. STUDENTS BEHAVIOUR

- Play by the rules of the game and understand that the official's decision is final. If there is a concern, raise this with the team captain who may politely discuss it with the referee.
- Verbal or physical abuse will not be tolerated and will result in expulsion from the game/competition.
- Be sporting. Support other teams as well as your own teammates.
- Be respectful of the coach and all the decisions he/she makes.
- Participate in the sport for your own enjoyment, not due to pressure from outside sources.
- Respect the rights and worth of every student-athlete, regardless of their gender, age, ability, ethnicity or religion
iii. PARENTS BEHAVIOUR
- Encourage your children to participate, but do not force them.
- Understand that they are participating for their own enjoyment, not yours.
- Place emphasis on your child's effort and participation rather than winning at all costs.
- Respect your child's coach and the decisions that he/she makes. Show appreciation for the time and effort that he/she puts into making these events happen.
- Never berate an official - Set a mature example.
- Respect the rights and worth of every student-athlete, regardless of their gender, age, ability, ethnicity or religion


## BY-LAW K. HEALTH AND SAFETY

- Students can not wear regular glasses whilst participating in contact and projectile sports, they must wear contact lenses or sports goggles.


## SISAC Underage Athlete Application Form

This document is intended for the application of underage players to join teams they are not eligible under the rules of the SISAC Handbook. Completion of this form and the application is required before players are approved to participate on teams out of the age category requested.

Guidelines for the purpose of requesting Underage Athletes for participation:
Requests for underage athlete participation should be based upon the philosophy of supporting the participation of the team in question in areas of safety and meeting eligibility requirements for numbers of players. Requests should not be made with the intention of Competitive Advantage or Development of Younger Players. At no time should younger players take the priority for participation over an eligible age player on a team.
Players will be considered for eligibility based on the following:

- Number of students requested (the guideline should be to meet the minimum required to support the safe participation of the team).
- Age and Grade of the Students (players should be as close to eligible grade as possible)
- The reason for the request for extra students
- Intention of the student participation (Players should not be chosen solely to increase the competitive level of the team at the expense of eligible athlete playing time)
